ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Sewerage System Improvements, September 2017 (Revised December 2018) Division 1A** will be received, by **CITY OF SANDERSVILLE**, at City Hall, 141 West Haynes Street, Sandersville, Georgia 31082, until **1:30 p.m.** local time, and Sealed Bids for the construction of **Division 1B** will be received at the same location until **2:30 p.m.** local time on **Tuesday, April 2, 2019** at which time the Bids received will be publicly opened and read. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of ninety (90) days. The Project consists of construction of:

Division 1A:

Base Bid: Rehabilitation of sanitary sewers by dig and replace including 6,670 L.F. of 8, 12, 15, 16 and 18 inch PVC & DIP sewers, including new services, existing service rehabilitation and 500 L.F. of video survey.

A-1: Rehabilitation of sanitary sewers by dig and replace including 2,435 L.F. of 8-inch PVC sewers, existing service rehabilitation, and 935 L.F. of video survey.

A-2: Rehabilitation of sanitary sewers by dig and replace including 2,169 L.F. of 8-inch PVC sewers, existing service rehabilitation, and 2,169 L.F. of video survey.

Division 1B:

Base Bid: Construct 10,190 L.F. of 8-inch PVC & DIP sewers, including new services, and 6,085 L.F. of force main.

A-1: Rehabilitation of sanitary sewers by dig and replace including 4,630 L.F. of 8-inch PVC sewers, existing service rehabilitation, and 4,630 L.F. of video survey.

Division Two:

No Bids will be accepted for Division Two.

Division Three:

No Bids will be accepted for Division Three.

Time of construction is **210** consecutive calendar days for Division 1A (add **45** days if Addition A-1 is awarded and add **45** days if Addition A-2 is awarded). Time of construction is **270** consecutive calendar days for Division 1B (add **60** days if Addition A-1 is awarded).

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Proposals for the complete work in one or more general contracts shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

All Bidders must have a State of Georgia Utility Contractors License and must employ a state "Utility Manager" certificate holder who will have oversight of all the work.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of **\$350.00** for drawings and specifications. Additional reduced sized drawings are available for **\$175.00** Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 30 days after receipt of Bids will receive a one-half (½) refund. Checks for Bidding Documents shall be payable to "Turnipseed Engineers." Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Upon receipt of all documents in undamaged condition within thirty (30) days after the date of opening of bids, one-half of the deposit will be refunded. The difference between the deposit and the amount refunded represents the cost of reproduction. No refund will be made for documents received after thirty (30) days or in damaged condition.

A pre-bid conference will not be held.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Bidders shall submit proof of qualifications to perform the Work as described in the Instructions to Bidders.

The Owner reserves the right to reject any or all bids and to waive informalities.
