**SEWERAGE SYSTEM IMPROVEMENTS**

**Proposals:** for the SEWERAGE SYSTEM IMPROVEMENTS will be received at the City Manager's Office of Social Circle City Hall located at 166 North Cherokee Road, Social Circle, GA, 30025, until 3:00 P.M. THURSDAY, JUNE 14, 2018. The project consists of:

Installation of approximately 2,447 L.F. of 8-inch PVC sanitary sewer line, 1,100 L.F. of 8-inch PVC water line, 7 manholes, 1 hydrant, erosion control measures and appurtenances.

Proposals will be reviewed by the City and will be awarded to the proposal most advantageous to the City. A copy of the proposal tabulation will be provided upon request.

**Work to Be Done:** The work to be performed by the General Contractor consists of but is not limited to the following major items:

1. Installation of approximately 2,447 L.F. of 8-inch PVC sanitary sewer line
2. Installation of approximately 1,100 L.F. of 8-inch ductile iron water line
3. 7 Manholes
4. 2 hydrants
5. Erosion Control Measures
6. Stormwater Monitoring
7. Time allotted for construction is 120 consecutive calendar days.

The street address, phone number, and fax number of contractors submitting proposals must be provided to ensure prompt delivery of any addenda.

All Bidders must have a State of Georgia Utility Contractor License and must employ a state "Utility Manager" certificate holder who will have oversight of all the work.

All proposals shall be accompanied by a Bid Bond drawn in favor of SOCIAL CIRCLE, GEORGIA, in the amount of at least 10% of the lump sum bid for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for SOCIAL CIRCLE, GEORGIA. Each bond shall be equal to 100% of the contract amount. The Bid Bond shall be forfeited to SOCIAL CIRCLE, GEORGIA as liquidated damages if the Bidder fails to execute the contract and provide Performance and Payment Bonds within ten (10) days after being notified that he has been awarded the contract.

The Owner reserves the right to reject any or all proposals, to waive informalities, and to re-advertise.
