**BID ITEM: CONSTRUCTION OF SEWERAGE SYSTEM IMPROVEMENTS
LITTLE RIVER WPCP – OUTFALL SEWER**

Electronic or sealed proposals will be received by the BOARD OF COMMISSIONERS OF COLUMBIA COUNTY, OFFICE OF THE PURCHASING AGENT, 500 FAIRCLOTH DRIVE, EVANS, GEORGIA 30809, until 12:00 P.M. local time THURSDAY, APRIL 19, 2018 at which place they will be publicly opened and read at 2:00 P.M. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of ninety (90) days.

All Bidders must have a State of Georgia Utility Contractors License and must employ a state “Utility Manager” certificate holder who will have oversight of all the work.

Bid Description: The work to be done consists of furnishing all materials, equipment and labor for the construction of:

OUTFALL SEWER

Installation of approximately 2,625 L.F. 36-inch D.I.P. sewer line, 484 L.F. of river crossing pipe and a river diffuser and modifications to the existing river diffuser, including appurtenances, 64 manholes, and stormwater monitoring. Time allotted for this work is 180 consecutive calendar days.

Proposals for the complete work in one general contract shall be made on the electronic forms provided.

All proposals shall be accompanied by a Bid Bond drawn in favor of Columbia County, Georgia, in the amount of at least ten percent (10%) of the lump sum bid for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for Columbia County, Georgia. Each bond shall be equal to one hundred percent (100%) of the contract amount. The Bid Bond shall be forfeited to Columbia County, Georgia as liquidated damages if the Bidder fails to execute the contract and provide Performance and Payment Bonds within ten (10) days after being notified that he has been awarded the contract. Letters of credit will not be accepted. Bid bonds for electronic bids should be submitted electronically using www.bidsync.com surety 2000.
